There were no restrictions on any shareholders of the Company casting votes on any of the resolutions at the 2026 AGM. None of the shareholders of the Company have stated their intention in the Company's circular dated 24 April 2026 to vote against or to abstain from voting on any of the resolutions at the 2026 AGM.
