主席報告書

Chairman's Statement

全年財務業績

截至二零二三年十二月三十一日止年度，王氏國際集團有限公司（「本公司」，連同其附屬公司統稱「本集團」）擁有人應佔利潤為港幣152,700,000元，而上一個財政年度則為港幣112,400,000元。

此乃主要由於EMS部門利潤增加港幣34,200,000元及物業持有部門利潤增加港幣168,000,000元被於二零二二年確認視為出售一間聯營公司之收益港幣117,100,000元及融資成本淨額增加港幣26,100,000元所抵銷。

本年度之每股盈利為港幣0.32元，而上一個財政年度則為港幣0.23元。截至二零二三年十二月三十一日止年度，本集團之收益為港幣3,185,700,000元，而上一個財政年度則為港幣3,466,700,000元。截至二零二三年十二月三十一日止年度之營運利潤為港幣215,100,000元，而上一個財政年度則為港幣241,200,000元。

股息

本公司已支付二零二三年度中期股息每股港幣0.03元（二零二二年：港幣0.02元）。董事現建議於二零二四年六月二十八日（星期五）派付末期股息每股港幣0.03元（二零二二年：港幣0.045元）予於二零二四年六月十二日（星期三）名列本公司股東名冊之股東。派付有關建議末期股息須待股東於本公司將於二零二四年六月五日（星期三）舉行之應屆股東週年大會（「股東週年大會」）上批准，方可作實。

FINAL FINANCIAL RESULTS

The profit attributable to owners of Wong's International Holdings Limited (the "Company", and together with its subsidiaries, the "Group") for the year ended 31 December 2023 amounted to HK\$152.7 million, as compared to HK\$112.4 million for the last financial year.

This was mainly attributable to the profit from EMS Division increased by HK\$34.2 million and profit from the Property Holding Division increased by HK\$168.0 million offsetting by the gains on deemed disposal of an associate of HK\$117.1 million recognised in 2022 and increase in net finance cost by HK\$26.1 million.

Earnings per share for the year was HK\$0.32 as compared to HK\$0.23 for the last financial year. The Group's revenue for the year ended 31 December 2023 was HK\$3,185.7 million, as compared to HK\$3,466.7 million for the last financial year. Operating profit for the year ended 31 December 2023 was HK\$215.1 million, as compared to HK\$241.2 million for the last financial year.

DIVIDENDS

The Company paid an interim dividend of HK\$0.03 (2022: HK\$0.02) per share for 2023. The Directors now recommend the payment of a final dividend of HK\$0.03 (2022: HK\$0.045) per share on Friday, 28 June 2024 to the shareholders whose names appear on the Register of Members of the Company on Wednesday, 12 June 2024. Payment of such proposed final dividend is subject to approval of the shareholders at the forthcoming annual general meeting (the "AGM") of the Company to be held on Wednesday, 5 June 2024.

就股東週年大會而暫停辦理股東登記手續

為確定出席股東週年大會並於會上投票之權利，本公司將於二零二四年五月三十日（星期四）至二零二四年六月五日（星期三）（包括首尾兩日）暫停辦理本公司股東登記手續，於該期間內不會辦理股份轉讓。如欲符合資格出席會議並於會上投票，務須於二零二四年五月二十九日（星期三）下午四時三十分前，將所有過戶表格連同有關股票，一併送達本公司之香港股份過戶登記分處卓佳標準有限公司，地址為香港夏慤道16號遠東金融中心17樓，以辦理登記手續。

就派發股息而暫停辦理股東登記手續

股息政策

為維持合理的投資回報及回饋股東之持續支持，本公司已採納股息政策，按本集團的利潤表現向股東派發股息。股息派付比率將會根據股東應佔利潤（不包括已計入綜合收益表的應佔合營企業／聯營公司利潤及虧損以及投資物業公允價值變動），並經考慮多個於宣派股息當時之因素後釐定，包括但不限於財務表現及預期的盈利能力、流動資金狀況及資本效率、遵守財務契約、來自附屬公司的股息收入、未來發展及承諾、潛在投資機遇，以及本公司之公司細則、百慕達法律及其他適用規則和規例內的相關條文。本公司亦或會在普通股息以外不時派發特別股息。

視乎不時的情況而定，股息建議及派付將由本公司董事會全權決定，及在適用情況下需經股東批准。概無保證將會就任何指定期間建議或派付任何特定金額的股息。

DIVIDEND POLICY

For the purpose of maintaining a reasonable return on investment and rewarding shareholders for their continued support, the Board has adopted a Dividend Policy for distribution of dividend to the shareholders in accordance with the Group's profit performance. The dividend payout ratio will be based on the profit attributable to the shareholders excluding share of profit and loss of joint ventures/associated companies and change in fair value of investment properties which have been recorded in the consolidated income statement after considering various prevailing factors at the time of declaration of dividend, including but not limited to financial performance and projected profitability, liquidity position and capital efficiency, compliance with financial covenants, dividends received from subsidiaries, future growth and commitments, potential investment opportunities, relevant provisions under the Company's bye-laws, laws of Bermuda and other applicable rules and regulations. The Company may also distribute special dividend from time to time in addition to the ordinary dividend.

Depending on the situation from time to time, dividend recommendation and payment shall be determined at the sole discretion of the Board and subject to the approval of shareholders, where appropriate. There is no assurance that dividends will be recommended or paid in any particular amount for any given period.

業務回顧

電子製造服務(「EMS」)部門

截至二零二三年十二月三十一日止年度，EMS部門之收益為港幣3,123,900,000元，而上一個財政年度則為港幣3,404,500,000元。EMS部門應佔分部利潤為港幣191,400,000元，較上一個財政年度港幣157,200,000元增加21.8%。分部純利增加歸因於營運效率提高。

物業持有部門

截至二零二三年十二月三十一日止年度，物業持有部門之收益為港幣61,800,000元，而上一個財政年度則為港幣62,200,000元。分部利潤為港幣79,900,000元，而上一個財政年度之分部虧損則為港幣88,100,000元。由虧轉盈乃因本集團及合營企業持有之物業價值降幅相對更低所致。物業價值之下降為未變現，亦對本集團之現金流量並無產生任何影響。本集團及合營企業所持有之物業主要用作租賃用途，於本年度內，租金收入並無任何重大變動。

REVIEW OF BUSINESS ACTIVITIES

Electronic Manufacturing Service (“EMS”) Division

Revenue for the EMS Division for the year ended 31 December 2023 was HK\$3,123.9 million, as compared to HK\$3,404.5 million for the last financial year. The segment profit attributable to the EMS Division was HK\$191.4 million, 21.8% increase as compared to HK\$157.2 million for the last financial year. The increase in the segment net profit was attributable to the improvement of operating efficiency.

Property Holding Division

Revenue for the Property Holding Division for the year ended 31 December 2023 was HK\$61.8 million, as compared to HK\$62.2 million for the last financial year. The segment profit was HK\$79.9 million, as compared to segment loss of HK\$88.1 million for last financial year. The turnaround was driven by the lower reduction on the value of properties held by the Group and the Joint Ventures. The decrease in the value of the properties is unrealised and did not have any impact on the Group's cash flow. The properties held by the Group and the Joint Ventures are mainly for leasing purposes and the rental income had no significant change during the year.

流動資金及財務資源

於二零二三年十二月三十一日，本集團之銀行信貸總額為港幣3,071,300,000元（二零二二年：港幣3,408,200,000元）。銀行貸款總額為港幣1,790,700,000元（二零二二年：港幣2,023,000,000元）。於二零二三年十二月三十一日，現金及現金等價物、短期銀行存款及受限制現金為港幣1,348,000,000元（二零二二年：港幣1,217,000,000元）。

於二零二三年十二月三十一日，本集團之銀行貸款淨額為港幣442,700,000元，而於二零二二年十二月三十一日則為港幣806,000,000元。本集團維持充足銀行信貸及銀行結存，以應對本集團製造業務及物業持有部門之現金需要。

本集團於二零二三年十二月三十一日之淨資產負債比率為0.10（二零二二年：0.19）。淨資產負債比率的計算方法為負債淨額除以總權益。負債淨額則由總銀行貸款及租賃負債減現金及現金等價物、短期銀行存款及受限制現金得出。

外匯及風險管理

本集團大部分銷售均以美元進行，成本及開支則主要以美元、港幣、日圓、人民幣及越南盾計算。本集團並無使用任何外匯對沖產品，與財務風險管理之審慎政策一致。本集團知悉人民幣匯價波動的貨幣風險，並將密切監察及積極管理所涉及的風險。

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 December 2023, the Group had a total of HK\$3,071.3 million (2022: HK\$3,408.2 million) of banking facilities. Total bank borrowings were HK\$1,790.7 million (2022: HK\$2,023.0 million). Cash and cash equivalents, short-term bank deposits and restricted cash were HK\$1,348.0 million as at 31 December 2023 (2022: HK\$1,217.0 million).

As at 31 December 2023, the Group had a net bank borrowing of HK\$442.7 million, as compared to HK\$806.0 million as at 31 December 2022. Sufficient banking facilities and bank balances are available to meet the cash needs of the Group for its manufacturing operations as well as Property Holding Division.

Net gearing ratio for the Group as at 31 December 2023 was 0.10 (2022: 0.19). The net gearing ratio was calculated as net debt divided by total equity. Net debt is calculated as total bank borrowings and lease liabilities less cash and cash equivalents, short-term bank deposits and restricted cash.

FOREIGN EXCHANGE AND RISK MANAGEMENT

Most of the Group's sales are conducted in United States dollars and costs and expenses are mainly in United States dollars, Hong Kong dollars, Japanese Yen, Chinese Renminbi and Vietnam Dong. Consistent with its prudent policy on financial risk management, the Group does not use any foreign exchange hedging products. The Group recognises the currency risk in the fluctuation of Chinese Renminbi and will closely monitor and actively manage the risk involved.

資本結構

本集團之資本結構包括銀行貸款、現金及現金等價物、短期銀行存款、受限制現金以及母公司擁有人應佔權益，當中包括已發行股本及儲備。

CAPITAL STRUCTURE

The Group's capital structure consists of bank borrowings, cash and cash equivalents, short-term bank deposits, restricted cash and equity attributable to owners of the parent, comprising issued share capital and reserves.

本集團資產之抵押

本集團資產之抵押詳情載於綜合財務報表附註30。

PLEDGES ON THE GROUP'S ASSETS

Details of the pledges on the Group's assets are set out in note 30 to the consolidated financial statements.

僱員

於二零二三年十二月三十一日，本集團聘用2,581名僱員。本集團所採納之薪酬政策為按僱員之工作性質、資歷及經驗釐定薪酬。除提供年終花紅及僱員相關保險福利外，本集團亦會基於僱員之個人表現發放酌情花紅。本集團之薪酬福利及政策會定期作出檢討。本集團亦向其僱員提供內部及外間培訓課程。

EMPLOYEES

As at 31 December 2023, the Group employed 2,581 employees. The Group adopts a remuneration policy which is commensurate with job nature, qualification and experience of employees. In addition to the provision of annual bonuses and employee related insurance benefits, discretionary bonuses are also rewarded to employees based on individual performance. The remuneration packages and policies are reviewed periodically. The Group also provides in-house and external training programs to its employees.

前景

二零二四年全球經濟環境錯綜複雜。一方面，通脹及利率高企以及地緣政治風險持續影響全球經濟增長。另一方面，通脹下行已為降低利率創造一定空間，惟時間及降幅仍不確定。上述因素將影響客戶對我們的需求及本集團的盈利能力。

半導體和部件的短缺已得到進一步緩解，且部件交付週期大幅縮短。本集團將繼續實施嚴格的成本節省及效率改善措施，以確保以最高效的方式服務我們的客戶。按目前的客戶訂單及預報，本集團預計二零二四年上半年EMS業務收益將稍微下降，原因為部分客戶因二零二三年重要材料短缺導致存貨過多，進而降低對我們的訂單預報。本集團預計一旦該等客戶消耗完過多庫存，則其訂購水平將恢復正常。

許多客戶因本集團於中國內地及越南均設有工廠而對其感興趣。本集團現正利用這優勢獲取更多銷售機會並擴展EMS業務客戶群。客戶對我們位於越南海陽省樓面積達30,000平方米之新生產設施進行資格認證的參訪有所增加。其將成為本集團日後增長的重要來源。

PROSPECTS

The global economic environment is complicated in Year 2024. On the one hand, high inflation and interest rates as well as geopolitical risks continue to impact global economic growth. On the other hand, declining inflation has created room for the lowering of interest rates although the timing and magnitude of the cuts remain uncertain. The above factors will impact demand from our customers and the profitability of the Group.

Shortages of semiconductors and components have further eased, and component lead times are much reduced. The Group will continue to implement stringent cost saving and efficiency improvement measures to ensure that our customers will be served in the most efficient manner. Based on current customer orders and forecasts, the Group expects that the revenue of the EMS business for the first half of Year 2024 will decrease slightly as some customers have reduced their order forecasts to us due to overstocking arising from shortage of critical materials in 2023. The Group expects that the ordering levels of those customers will resume to normal once they have consumed their excess inventory.

Many customers are interested in the Group for having factories in both Mainland China and Vietnam. The Group is taking this advantage to obtain more sales opportunities and expand the customer base of the EMS business. Customer visits to qualify our new production facility in Hai Duong Province, Vietnam, with a floor area of 30,000 square meters have increased. It will be an important source of future growth for the Group.

前景（續）

本集團直接或間接持有之商業物業已幾乎全數租出，為本集團帶來穩定收入。貸款利率預期於二零二四年上半年維持在高水平。本集團已採取措施對沖利率不斷上升的風險。

本公司及其全資附屬公司王氏電子有限公司連續十二年獲香港社會服務聯會頒發「商界展關懷」標誌。這些嘉許為對本集團積極參與社區活動及作為良好企業市民的認可。

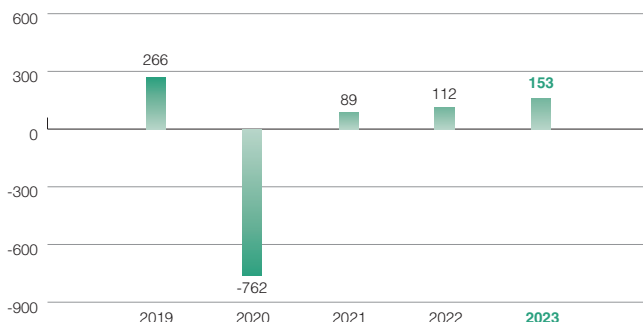
港幣百萬元 HK\$million

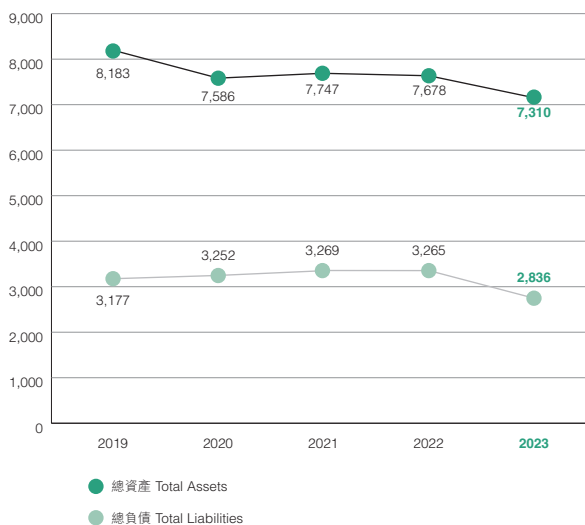

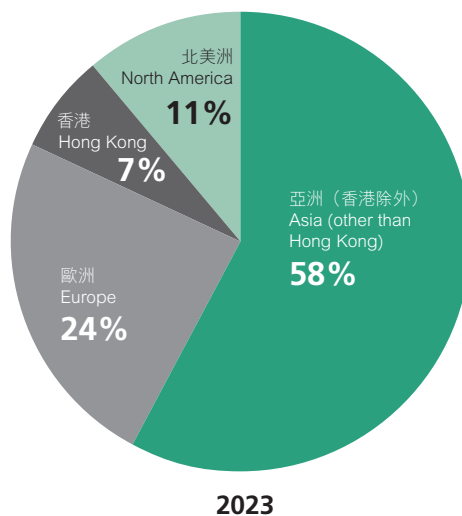
Total Assets and Total Liabilities

The option period of a particular option is the period during which the option can be exercised, such period to be determined and notified by the Board to each grantee at the time of making the offer, and in any event such period of time shall not expire later than 10 years from the date of grant.

6. Minimum period for which an option must be held before it can be exercised

Unless otherwise determined by the Board at its sole discretion, there is a minimum period of 1 year for which an option must be held after its date of grant before such an option can be exercised under the terms of the Scheme.

7. Amount payable on acceptance of the option and the payment period

To accept the grant of an option, HK\$10 as consideration for the grant of an option must be paid by the grantee to the Company within 21 days from the date on which an offer letter is delivered to the grantee.

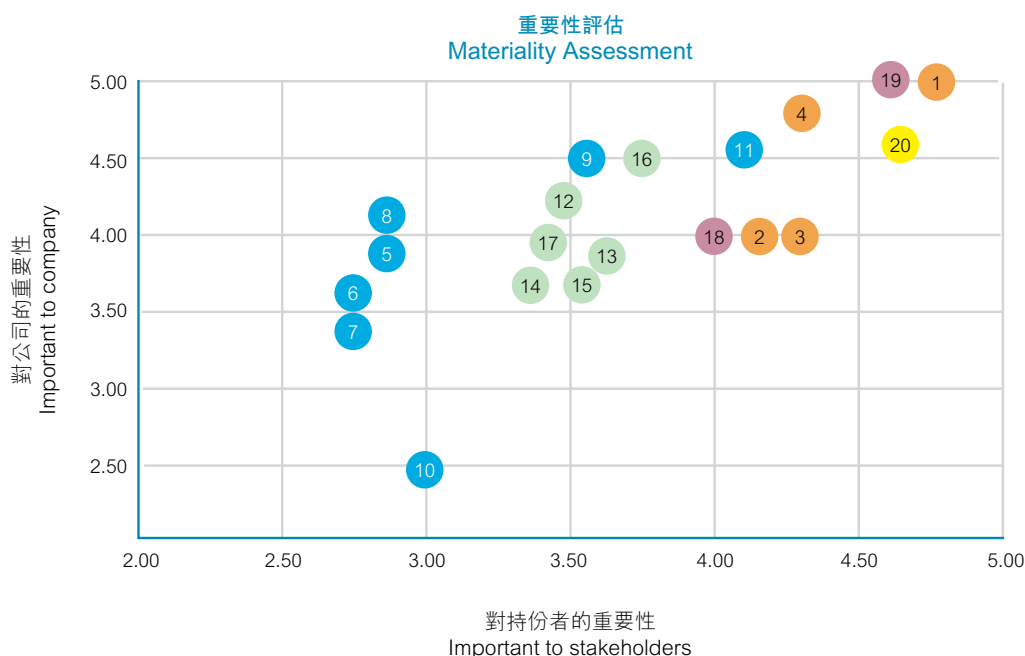

排放及節約能源

我們致力加強及提升環保設施，並改良處理及減少生產過程中與有害元素相關廢棄物及排放物的能力。

我們的廢氣排放主要來自公司汽車。於二零二三年，我們產生的氮氧化物、硫氧化物及顆粒物分別為1,614.2公斤、1.05公斤及115.62公斤。與二零二二年比較，減少主要是由於二零二三年當地車輛運輸所需的運輸量有所減少。相關部門已經採取措施，將汽車維持於良好狀態，以儘量減少廢氣排放。

我們的溫室氣體排放主要來自用電、公司汽車及生產機械的碳排放。於二零二三年，我們產生的二氧化碳排放為17,619噸，耗電量為29,833,158千瓦時，與二零二二年相比增加0.26%，此乃由於二零二三年越南廠房開始大規模生產。本集團認為能源效益對減少排放溫室氣體尤其重要。

我們定期由政府認證實驗室進行國際標準及政府法規相關的環境測試。

We have taken rigorous efforts to enhance and upgrade the environmental facilities and improve the capabilities in processing and reducing wastes and emissions related to hazardous elements in the manufacturing process.

Our air emissions were generated mainly by company vehicles. In 2023, our NO_x, SO_x and PM were 1,614.2 kgs, 1.05 kgs and 115.62 kgs respectively. Comparing with the result in 2022, the decrease was mainly due to shipment required local vehicle transportation decrease in 2023. Relevant departments have been taking measures to maintain vehicles in good conditions in order to minimise air emission.

Our greenhouse gas emissions were contributed mainly by electricity consumptions, company vehicles and carbon emissions from the production machines. In 2023, our CO₂ emission was 17,619 tons and electricity consumptions was 29,833,158 kwh. Comparing with the result in 2022, there was 0.26% increase due to the Vietnam plant started mass production in 2023. The Company considered great importance on energy efficiency to minimise the greenhouse gas emission.

We conducted regular environmental testing through government certified laboratories with respect to international standards and government laws and regulations.

Actions we have taken to reduce air emissions, emission of CO₂, energy consumption; and improve energy efficiency include:

- Replace low efficiency conditioner units;
- Optimize the production areas and production lines usage to save energy;
- Turn company cars from oil to electrical;
- Optimize the air conditioning temperature without affecting humidity at the production floors;
- Continue the effort to replace part of the electricity by solar energy;
- Explore more opportunity to save energy, i.e.: applying iPaint to the roof of a production building of our factory in Shenzhen;
- Installed variable frequency devices of air conditioning systems;
- Replaced common lamps with LED;
- Upgraded HVAC system; and
- Continue the trees plantation around our manufacturing facilities to help absorbing carbon emissions.

用水

我們致力在營運中有效節約用水及已採取以下節約用水方案：

- 提倡及鼓勵僱員支持節約用水方案；
- 減少冷水機運行時間，提高利用率；
- 利用新技術及高效率升級去離子水系統；
- 控制衛生間及公共區域的管道水閥，將水閥流量降低20%，以節約用水；及
- 為衛生間更換感應式水龍頭。

二零二三年的耗水量為200,521噸，較二零二二年減少31%，主要由於用水效率提升。

廢棄物管理

於二零二三年，有害廢棄物及無害廢棄物分別為152噸及1,147噸。有害廢棄物較二零二二年增加34.4%，主要是由於電路板廢料及廢活性炭的數量增加，而無害廢棄物增加18.9%，主要由於越南廠房於二零二三年開始大規模生產。為創造一個可持續發展的社會，我們對有害廢棄物及無害廢棄物進行嚴格分類，有害廢棄物會儲存於特定地區，並由訓練有素的員工按照工作指引處理，棄置則交由認可代理商負責。

Water Consumption

We endeavor to conserve water effectively in the operations and implemented water conservation programs as follow:

- Promoted and motivated employees to support the water-saving program;
- Reduced chiller running time and improved the utilization;
- Upgraded the Deionised water system with new technology and high efficiency;
- Control the pipe water valve in toilet and public area, reduce the water valve flow rate by 20% to save water; and
- Replaced with infrared sensor faucet in toilet.

In 2023, water consumption was 200,521 tons which was decreased 31% by comparing with the result in 2022, mainly due to improve the efficiency of water usage.

Waste Management

In 2023, hazardous wastes and non-hazardous wastes were 152 tons and 1,147 tons respectively. Comparing with the result in 2022, hazardous wastes increased 34.4% mainly due to the volume increased for the PCB scrap materials and also waste activated carbon. Non-hazardous wastes increased by 18.9% mainly due to the Vietnam plant started mass production in 2023. With the aim to create a sustainable society, we conduct strict classification of hazardous wastes and non-hazardous wastes, and hazardous wastes are stored in special areas, handled by well-trained employees in accordance with working instructions and disposed through accredited vendors.

廢棄物管理（續）

各廠房均有提倡及推行減廢及循環再用。我們會安排回收波峰焊接機的錫渣以減少有害廢棄物。部份化工容器及包裝物料會交回供應商循環再用及回收。我們亦使用循環再用箱以減少耗用包裝物料。

使用其他資源

我們使用包裝物料保護產品，以減少運輸中損壞的風險。於二零二三年，我們使用1,598噸包裝物料，使用量比較二零二二年高1.2%，乃主要由於越南廠房於二零二三年開始大規模生產，運輸量有所增加。為了減少包裝物料的使用，我們為更多的客戶推行使用循環周轉箱，以替代紙箱。

氣候變化

氣候變化主要是由燃燒化石燃料用於能源、煉鋼、水泥生產以及森林喪失而排放的溫室氣體引致。氣候變化的影響已波及全球經濟。本集團深知應對與氣候相關的挑戰及機遇以及支持向低碳經濟轉型的重要性。本集團已識別及評估潛在氣候相關風險，包括實體風險及轉型風險，以及其對業務的潛在財務影響。本集團已制定氣候變化策略，並採取多種行動，以應對氣候變化。此外，本集團定期審閱相關法律法規，以確保及時更新並遵守相關規定。

Waste Management (continued)

Waste reduction and recycling have been promoted and implemented in the factories. We recycled solder dross from the wave soldering machines to reduce the amount of hazardous wastes. We returned some of the chemical containers and packaging to the suppliers to reuse and recycle. We used recycle boxes to reduce the use of packing materials.

Other Use of Resources

Package materials are used to protect our products in order to minimise the risk of damage during transportation. In 2023, package materials used was 1,598 tons which was 1.2% higher than the usage in 2022, mainly caused by the Vietnam plant started mass production and shipment increase in 2023. To reduce the usage of packing materials, we implemented recycle box for more customers to replace the carton box.

Climate Change

Climate change is mainly caused by the emission of greenhouse gases due to burning fossil fuels for energy uses, steelmaking, cement production and forest loss. The impact of climate change has affected the economies throughout the world. The Group recognized the importance of addressing the climate related challenges and opportunities and supporting the transition to the low carbon economy. The Group has identified and assessed the potential climate related risks including physical risks and transition risks as well as their potential financial impacts to the business. The Group has developed a climate change strategy and formulated various actions to cope with climate change. Also, the Group reviews relevant law and regulations periodically to ensure the requirements are timely updated and followed.

本公司採用碳中和理念，致力於通過各種節能計劃（例如使用低排放或可再生能源及植樹造林等）盡量減少能源消耗並提高日常營運的能效，從而減少溫室氣體排放。

本集團擁有三個製造工廠，分別位於深圳、蘇州及越南。有關工廠並不位於可能因持續高溫或極端惡劣天氣情況而中斷本集團製造活動的地區。本集團亦意識到氣候變化的影響，包括全球變暖及天氣模式的變化，可能會影響我們的營運及員工安全。本公司已針對極端天氣事件採取適當措施，根據政府規定為所有員工制定全面的颱風及暴雨警告指引；嚴格執行員工在高溫天氣下工作的措施，並遵守政府規定；擁有相應設施，防止相關員工因天氣炎熱而在高溫環境下工作，並密切留意天氣資訊，及時安排工作。

本集團亦積極尋求潛在商機，以提升營運韌性及潛在業務增長。本集團於採購流程中將氣候變化納入考慮，使用更多環保及可回收材料，增加可再生能源的使用，改善生產過程中的能源消耗。隨著客戶對可持續、綠色及低碳產品需求的增長，此舉將為我們的日後業務帶來積極影響。

The Company is adopting the carbon neutrality concept and is committed to reduce the greenhouse gases by minimising the energy consumption and improving the energy efficiency from our daily operations through various energy saving programs for examples, using lower emission or renewable energy and tree plantation etc.

Our Group has three manufacturing factories located in Shenzhen, Suzhou and Vietnam. They are not located in areas where disruption to the Group's manufacturing activities may happen due to sustained high temperature or extreme bad weather conditions. The Group also recognises the impacts of climate change which includes both global warming and weather patterns change can affect our operation and safety of its people. The Company has adopted appropriate measures for extreme weather events. The Company has comprehensive guidelines to all employees for typhoon and rainstorm warnings in accordance with the government regulations. The Company has strictly followed the measures for employees working in hot weather and comply with the government regulations. The Company has the corresponding facilities to prevent the related employees working in high temperature environment due to hot weather and closely monitor the weather information for work arrangements on time.

The Group is also actively looking for the potential business opportunities to enhance the operational resilience and potential business growth. The Group is incorporating climate change considerations in procurement processes to use more environmental friendly and recycled materials, increase the use of renewable energy and improve the energy consumption in our production process. As customers demand for sustainable, green and low carbon products grows, this can lead to a positive impact on our future business.

Targets

We aim to minimise the impacts to the environment while our electronic manufacturing business consume significant amount of energy and resources. By implementing lean manufacturing, automation and optimising logistics within the factories, we strive to improve our resources and energy efficiencies, productivity and to reduce the use of raw materials. Environmental targets and plans are conveyed to the employees to maintain an environmental cautious workplace.

The Group is committed and has formulated a series of environmental measures and set up the targets to reduce its operational impact on the environment.

The Company has set the targets in Year 2025 to reduce intensities of energy use, greenhouse gas emission, waste and water consumption by 5% compared to the result of Year 2021.

During 2023, we have applied iPaint to the roof of a production building of our factory in Shajing, Shenzhen. iPaint is an energy-saving product developed by a local university, which comprises an electricity-free cooling coating to be painted on the roof or external wall for the cooling of the room. Our initial trial run indicates that the employment of the product has the effect of reducing room temperature by 5-6% and electricity usage should be reduced as a result.

Our commitment to staff development is also aligned with the expectation that authorised institutions should engage and deploy personnel with sufficient skills, knowledge and experience for the discharge of their duties. There are reinforcement and refresher training programs to ensure that employees are in possession of the latest information and skills for carrying out their duties with the highest standards, for examples, leadership training, team building and supervisory skills, safety and sales product and technical training, etc. In addition, we also sponsor and provide time-off for employees who take external training programs relevant to their duties and responsibilities. We have internal certified trainers to train relevant employees for required technical certifications. Employees may also join external training programs on certifications required. We also recruit some graduates each year to take up first level jobs and develop them to the upper levels, for examples, technicians, buyer, planner, etc.

In addition, certain specific positions, such as nurse and safety officers, are employed to ensure that the workplace is safe and that safety device and protections are adequate to avoid any possible injuries arising from our work. An examination of whether the workplace is contaminated by particles is conducted by a government-recognised third party on an annual basis. We also arrange relevant workers to take body check periodically. Furthermore, we provide our employees with regular intensive training programs to alert their safety awareness.

To provide relief on job pressure, we organise and encourage employees to participate the recreational activities organised by the Group such as annual dinner, Christmas party, birthday gathering, interest class and outing from time to time.

We have suppliers from different regions globally. A supplier management system is established for selecting and qualifying suppliers to ensure the quality of the purchased materials complies with the relevant laws and regulations. Based on adequate qualification, suppliers are subject to assessment and on-site audits on product quality as well as capabilities and quality consistency tests made by our quality department. The Group only makes purchases from suppliers listed in approved vendor list. A new supplier can only be added to the approved vendor list upon detailed assessment and approval according to the supplier management system. The suppliers recognise the importance of our requirements on business ethics, health and safety environment and public responsibilities. The suppliers need to confirm to meet the requirements and are checked according to supplier management system before approval. Regular review is conducted with key suppliers on their scorecard performance. Suppliers fail to meet the Group's standards may result in termination of the cooperation.

本公司致力制定良好的企業管治常規及程序，所遵行的企業管治原則著重高質素之董事會、有效之風險管理及內部監控，以及對全體股東之透明度及問責性。

董事認為，於截至二零二三年十二月三十一日止年度內，本公司已遵守香港聯合交易所有限公司（「聯交所」）證券上市規則（「上市規則」）附錄C1第二部分所載企業管治守則（「企業管治守則」）之守則條文，惟以下除外：(a)主席及行政總裁之職位由同一人兼任，這與守則條文C.2.1條有偏離；(b)本公司現有的舉報政策不接受不具名舉報，這與守則條文D.2.6條有偏離；及(c)本公司薪酬委員會現行的職權範圍並未包括審閱及／或批准上市規則第十七章所述有關股份計劃的事宜之職責，這與守則條文E.1.2(i)條有偏離。詳情分別於本報告書「主席兼行政總裁」、「風險管理及內部監控」及「薪酬委員會」各段內闡述。

二零二三年期間及直至本報告書日期，為確保持續遵守企業管治守則之守則條文（上述若干偏離除外），董事會已檢討本公司企業管治常規及在適當情況下作出所須修改。詳情於本報告書內披露。

The Company is committed to the establishment of good corporate governance practices and procedures. The corporate governance principles of the Company emphasise a quality Board, effective risk management and internal control, transparency and accountability to all shareholders.

In the opinion of the Directors, during the year ended 31 December 2023, the Company has complied with the code provisions of the Corporate Governance Code (the “CG Code”) as set out in Part 2 of Appendix C1 to the Rules Governing the Listing of Securities (the “Listing Rules”) on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”), except that (a) the positions of Chairman and Chief Executive Officer are occupied by the same person, which deviates from code provision C.2.1; (b) the existing Whistleblowing Policy of the Company does not accept anonymous reporting, which deviates from code provision D.2.6; and (c) the current Terms of Reference of the Remuneration Committee of the Company do not include the responsibility to review and/or approve matters relating to share schemes under Chapter 17 of the Listing Rules, which deviates from code provision E.1.2(i). Details are explained in this Report under the paragraphs “Chairman and Chief Executive Officer”, “Risk Management and Internal Control” and “Remuneration Committee”, respectively.

During the year of 2023 and up to the date of this Report, the Board had reviewed and, where appropriate, made necessary changes to the corporate governance practices of the Company in order to ensure continued compliance with the code provisions of the CG Code (other than certain deviations mentioned above). Details are disclosed in this Report.

董事之證券交易

本公司已採納上市規則附錄C3所載上市發行人董事進行證券交易的標準守則（「標準守則」）。經向全體董事作出具體查詢後，所有董事已確認於截至二零二三年十二月三十一日止年度內已遵守標準守則所載的規定標準。

董事會及行政委員會

董事會已擬備一份保留予董事會批准之事務清單。根據清單，董事會對本集團企業管治常規的制定和實施、本公司的可持續發展表現、貫徹達成業務計劃及遵守法定與企業義務負最終責任。董事會會議上討論之事項包括制定本集團策略及政策；批准重大業務、管理及財政事宜、主要收購事項、出售事項及資本承擔；批准有關本公司組織章程及股本之事宜，以及更換董事會成員及核數師；成立董事會轄下委員會以進行授權；審閱企業管治及維持適當的風險管理及內部監控系統。

本公司已成立行政委員會，委員會獲董事會授予一般權力，以處理本公司之行政及日常營運，惟載於上述保留予董事會批准之事務清單內之事項除外。行政委員會現由五名執行董事組成，分別為王忠秣先生（行政委員會主席）、王賢敏女士、陳子華博士、熊永順先生及陳偉明先生。

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix C3 to the Listing Rules. Having made specific enquiry to all Directors, all Directors confirmed that they had complied with the required standard set out in the Model Code during the year ended 31 December 2023.

BOARD OF DIRECTORS & ADMINISTRATIVE COMMITTEE

The Board has a schedule of matters reserved for its approval. Pursuant to the schedule, the Board is ultimately responsible for the development and implementation of the Group's corporate governance practices, sustainable performance of the Company, consistent achievement of business plans and compliance with statutory as well as corporate obligations. Matters which may be discussed in Board meetings include the formulation of the Group's strategies and policies; approval of significant business, management and financial matters, major acquisitions, disposals and capital commitments; approval of matters relating to the Company's constitution and share capital, and change of board members and auditors; delegation of powers by establishment of board committees; review of corporate governance and the maintenance of appropriate risk management and internal control systems.

The Company has established an Administrative Committee which has all the general powers delegated by the Board to deal with administration and daily operation of the Company save as those matters set out in the schedule of matters reserved to the Board mentioned above. The Administrative Committee currently comprises five Executive Directors, namely Mr. Wong Chung Mat, Ben (Chairman of the Administrative Committee), Ms. Wong Yin Man, Ada, Dr. Chan Tsze Wah, Gabriel, Mr. Hung Wing Shun, Edmund and Mr. Chan Wai Ming, Hermes.

董事會及行政委員會（續）

行政委員會亦向管理層指派多項特定工作，當中包括編製賬目；執行董事會所批准之策略及政策；日常監控預算；執行特定業務及工作項目；執行企業管治、風險管理及內部監控程序以及其他合規事宜。管理層在有需要時向行政委員會（及其他獲授權之董事會轄下委員會）提呈報告以供其審閱及作出指引。

本公司已列載其願景、使命及核心價值。本公司致力於成為先進技術的領導者及服務供應商，為人類、社會、客戶、股東及僱員作出貢獻。董事會於高層及中層管理人員的協助下負責在本公司各個層級貫徹發展及推廣符合其預期的企業文化，包括以道德、客戶渴求、尊重、團隊合作、開放、實效管理、能力、對成功的承諾、功績及卓越為重點的核心價值觀。

為確保根據證券及期貨條例第XIVA部及上市規則之規定，以平等、適時、有效、準確且恰當之方式發佈內幕消息，本公司已委派具備相關知識及專長之高級職員與行政人員，協助董事會評估潛在內幕消息之性質及重要性，及判定是否須經董事會批准後向公眾披露。相關程序及文件須由本公司之內控合規部審閱。有可能管有內幕消息之高級職員及相關僱員會持續接受有關處理及匯報潛在內幕消息之培訓。此外，為減低擅自披露或不一致披露之風險，只有經授權人士方可與投資者、分析員、傳媒及其他公眾人士討論本公司之企業事宜。

The Administrative Committee also delegates specific tasks to the management, which includes the preparation of accounts; implementation of strategies and policies approved by the Board; day-to-day monitoring of budgets; implementation of specific business and work projects; implementation of corporate governance, risk management and internal control procedures and other compliance matters. Management presents reports to the Administrative Committee (and other delegated Board Committee) for its review and guidance whenever necessary.

The vision, mission and core values of the Company have been set out. The Company is committed to becoming an advanced technology leader and service provider to contribute to our humanity, society, customers, shareholders and employees. The Board, assisted by senior and middle management, is responsible to develop and promote a desired company culture in alignment therewith throughout all levels of the Company, including the core values focus on ethics, customer passion, respect, teamwork, openness, managing for results, competence, commitment to success, merit and excellence.

In order to ensure equal, timely, effective, accurate and proper disclosure of inside information under the requirements of Part XIVA of the Securities and Futures Ordinance and the Listing Rules, the Company has identified a team of officers and executives with knowledge and expertise to assist the Board for assessing the nature and materiality of potential inside information and determining whether public disclosure is required subject to Board approval. The procedures and documentation in this relation are under review of the Company's Internal Compliance Control Department. Continuous training shall be provided to officers and relevant employees (who are likely to be in possession of inside information) for handling and reporting potential inside information. Also, to minimise the risk of unauthorised or inconsistent disclosure, only designated persons are authorised to discuss the Company's corporate matters with investors, analysts, the media and other members of the public.

本公司制定了各種機制，以確保董事會獲得獨立的觀點和意見。該等機制包括(i)就提名及委任董事會成員而採納正式、合宜及透明的程序，以確保提名及委任的權力歸屬提名委員會及董事會整體；(ii)執行董事及獨立非執行董事的組成平衡且符合上市規則項下之獨立性標準；(iii)強調董事會成員多元化為作出客觀決定之重要推動因素；(iv)提倡董事會會議進行開放性討論的文化；(v)於有需要時建立董事會轄下委員會，專責從事董事會授權明確界定的職能；及(vi)董事會及其委員會可通過其他渠道獲得獨立的觀點和意見（如外部獨立專業建議）以協助其履行職責，費用由本公司支付。

董事會現時由五名執行董事及四名獨立非執行董事組成。董事之個人資料（包括董事會成員間之關係）刊載於本年報第21至25頁內。

董事會於二零二三年曾舉行四次定期會議，會議大約每季舉行一次，以討論本公司之整體策略、經營、財務表現、股息支付、風險管理及內部監控系統、董事薪酬以及企業管治常規事宜。

To ensure independent views and input are available to the Board, various mechanisms have been established by the Company. Such mechanisms include (i) adoption of a formal, considered and transparent procedure for nomination and appointment of Board members to ensure that the power to nominate and appoint is rested on the Nomination Committee and the Board as a whole; (ii) a balanced composition of Executive and Independent Non-executive Directors fulfilling the independence criteria under the Listing Rules; (iii) emphasis on board diversity as an important driver to enable objective decisions to be made; (iv) promote a culture of openness during discussion at board meetings; (v) establishment of Board Committees to specialize in clearly-defined functions delegated by the Board whenever necessary; and (vi) the Board and its Committees may access to other channels where independent views and input are available (e.g. external independent professional advice) at the Company's expense in order to assist the performance of their duties.

The Board currently comprises five Executive Directors and four Independent Non-executive Directors. The biographical details of the Directors (including relationships among the members of the Board) are set out on pages 21 to 25 of this Annual Report.

The Board held four regular Board meetings in 2023 at approximately quarterly intervals to discuss the overall strategy, operation, financial performance, dividend payments, risk management and internal control systems, Directors' remuneration and corporate governance practices.

主席兼行政總裁

王忠秣先生為本集團主席兼行政總裁，自二零零三年二月起一直兼任這兩個職位。在容許兩個職位由同一人擔任時，本公司已考慮以下事項：

- (a) 兩個職位均須對本集團業務具備透徹了解及豐富經驗。本集團內外均難以遇到同時具備合適知識、經驗及領導才能之人選。倘任何一個職位由不符合資格之人士擔任，可能會拖累本集團之表現。
- (b) 本公司相信，董事會及其獨立非執行董事之監察可提供一個有效之制衡機制，並確保可足夠代表股東利益。

獨立非執行董事

本公司認為獨立非執行董事由工業、財務、法律及資訊科技專才組成，能夠就制定策略及其他財政或監管規定向董事會及管理層提供意見。根據上市規則之規定，獨立非執行董事已分別向本公司提供有關其獨立性之年度確認書。本公司視所有獨立非執行董事為獨立。

本公司現任獨立非執行董事概無指定任期，惟須根據本公司之公司細則第112條在本公司股東週年大會上輪值告退並接受重新選舉。

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Mr. Wong Chung Mat, Ben is the Group's Chairman and Chief Executive Officer and has occupied these two positions since February 2003. In allowing the two positions to be occupied by the same person, the Company has considered the following:

- (a) Both positions require in-depth knowledge and considerable experience of the Group's business. Candidates with the suitable knowledge, experience and leadership are difficult to find both within and outside the Group. If either of the positions is occupied by an unqualified person, the Group's performance could be gravely compromised.
- (b) The Company believes that the supervision of the Board and its Independent Non-executive Directors can provide an effective check and balance mechanism and ensures that the interests of the shareholders are adequately represented.

INDEPENDENT NON-EXECUTIVE DIRECTORS

The Company is satisfied that its Independent Non-executive Directors comprise a good mix of industrial, financial, legal and information technology expertise to advise the Board and the management team on strategy formulation and other financial or regulatory requirements. Pursuant to the requirement in the Listing Rules, each of the Independent Non-executive Directors has provided an annual confirmation of independence to the Company. The Company considers all of the Independent Non-executive Directors as independent.

The existing Independent Non-executive Directors of the Company are not appointed for a specific term but subject to retirement by rotation and re-election at the annual general meeting of the Company under Bye-law 112 of the Bye-laws of the Company.

薪酬委員會

本公司已成立薪酬委員會，由兩名獨立非執行董事，包括楊孫西博士（薪酬委員會主席）及葉天養先生，以及一名執行董事，即陳子華博士所組成。

根據企業管治守則，薪酬委員會已採納一種顧問模式，據此，薪酬委員會將擔當向董事會提供建議之角色，而批准執行董事及高級管理層薪酬之最終權力，則保留予董事會。薪酬委員會之主要責任包括就本公司全體董事及高級管理層之薪酬政策及架構提供建議、因應董事會所訂企業方針及目標而檢討及批准管理層之薪酬建議，並就董事及高級管理層之薪酬提供建議。薪酬委員會現行的職權範圍並未包括守則條文E.1.2(i)條項下所載審閱及／或批准上市規則第十七章所述有關股份計劃的事宜之職責。本公司現有購股權計劃（「該計劃」）是一項以僱員及其他合資格參與者為受益人的傳統計劃。該計劃的實施受本公司股東所採納的計劃規則內之正式及具透明度的程序所規管，包括在必要時須取得董事會、獨立非執行董事或股東明確批准的規定。董事會整體被視為可更切實有效地履行監督該計劃相關事宜的職責。授予董事或高級管理人員的任何購股權將構成其個人薪酬待遇的一部分，因此屬於薪酬委員會範圍。

REMUNERATION COMMITTEE

The Company has established a Remuneration Committee which comprises two Independent Non-executive Directors, namely Dr. Yu Sun Say (Chairman of the Remuneration Committee) and Mr. Alfred Donald Yap, and one Executive Director, namely Dr. Chan Tsze Wah, Gabriel.

Pursuant to the CG Code, an advisory model has been adopted by the Remuneration Committee under which the Remuneration Committee shall perform an advisory role to the Board, with the Board retaining the final authority to approve Executive Directors' and senior management's remuneration. The principal responsibilities of the Remuneration Committee include making recommendations on the Company's policy and structure for all Directors' and senior management's remuneration, reviewing and approving the management's remuneration proposals with reference to the Board's corporate goals and objectives, and making recommendations on the remuneration of Directors and senior management. The current Terms of Reference of the Remuneration Committee do not include the responsibility under code provision E.1.2(i) to review and/or approve matters relating to share schemes under Chapter 17 of the Listing Rules. The existing share option scheme (the "Scheme") of the Company is a traditional scheme for the benefit of the employees and other eligible participants. Implementation of such Scheme is governed by formal and transparent procedures under the scheme rules adopted by the shareholders of the Company, including the requirements for specific approval from the Board, Independent Non-executive Directors or shareholders where necessary. It is considered that the Board as a whole is more efficient and effective for discharging the responsibility to oversee matters relating to the Scheme. Any share options granted to a Director or senior management will form part of the individual remuneration package and therefore fall under the scope of the Remuneration Committee.

本公司之提名政策旨在作為指引，以確保在提名具備合適經驗及能力之董事時有正式、合宜及透明的程序可循，以維持及改善本公司之競爭力。按照該政策，倘需要新董事或替任董事，須根據來自現任董事會成員、管理團隊、認識候選人的其他人士及（如適合）專業獵頭公司的推薦意見或推介，編製一份候選董事名單。提名委員會須按候選董事之品格、誠信、承諾、知識及能力、觀點多元化（參考本公司董事會成員多元化政策）、於其領域之成就、專業或個人聲譽、與董事會現行需要相關之特定經驗或專業知識進行初步評估，而倘為新候選獨立董事，則須評估其是否被視為獨立。提名委員會其後須篩選及推薦一名或以上候選人進行面試。最後，須推薦最合適的人選予全體董事會以作考慮。於釐定退任董事是否符合資格於本公司股東大會上重選連任時，提名委員會須考慮該退任董事之貢獻及上文所載之其他相關標準；隨後向董事會作出建議以供考慮。

NOMINATION COMMITTEE (continued)

The Company's Nomination Policy is to serve as a guideline in order to ensure that there is a formal, considered and transparent procedure for nomination of Directors with suitable experience and capabilities to maintain and improve the competitiveness of the Company. According to the Policy, where a need is identified and arises for a new Director or replacement Director, a list of potential candidates should be compiled based on recommendations or referrals from existing Board members, management team, other individuals who know the candidates and, if it deems appropriate, a professional search firm. The Nomination Committee shall conduct an initial evaluation of the potential candidates based on the character, integrity, commitment, knowledge and ability, diversity of perspectives (with reference to the Board Diversity Policy of the Company), accomplishment in his/her own field, professional or personal reputation, particular experience or expertise relevant to the current needs of the Board, and in case of a new Independent Director candidate, whether he would be considered as independent. The Nomination Committee shall then select and recommend one or more candidates for interview. Lastly, the best available candidate shall be recommended for consideration by the Board as a whole. For determining whether a retiring Director is eligible for re-election at a general meeting of the Company, the Nomination Committee shall consider the contribution of such retiring Director and other relevant criteria set out above; and then make recommendation to the Board for consideration.

多元化

本公司深明董事會成員多元化之裨益，並相信均衡的董事會成員組成將提升董事會之表現及推動本公司之成功。有見於此，董事會已採納董事會成員多元化政策。該政策應與上文所述提名政策一併閱讀。

董事會成員多元化政策規定，設計董事會成員組成時，應從多方面考慮董事會成員多元化，以支持本公司實現策略性目標及維持可持續發展。甄選人選時將以一系列多樣的觀點為基準，包括（但不限於）性別、年齡、種族、文化及教育背景、專業經驗、技能及知識。董事會亦將考慮本身的業務模式及具體需要。最終將取決於所挑人選的長處及可為董事會提供的貢獻。

董事會認為本公司現任董事會大致達到觀點多元化，包括性別、年齡、教育背景、專業經驗、技能及知識。避免董事會成員性別單一的目標已達成。董事會現由各自於工業、財務、法律及資訊科技領域擁有獨特知識及經驗之個別董事所組成。本公司將繼續保持其董事會成員多元化，並當有需要填補空缺時，在不損害董事會質素的前提下，提升性別及年齡多元化為特定目標。

本公司致力於發展性別平等，將其作為全集團不同部門間組織文化的一部分。於二零二三年十二月三十一日，在本集團全體員工（包括高級管理層）中男性佔44.5%及女性佔55.5%。

DIVERSITY

The Company recognises the benefits of having a diverse Board and believes that a balanced Board composition will contribute towards the performance of the Board and success of the Company. In view of this, a Board Diversity Policy has been adopted by the Board. Such Policy should be read in conjunction with the Nomination Policy mentioned above.

The Board Diversity Policy provides that, in designing the Board's composition, Board diversity shall be considered from a number of aspects in supporting the attainment of the strategic objectives and sustainable development of the Company. Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, ethnicity, cultural and educational background, professional experience, skills and knowledge. The Board will also take into account factors based on its own business model and specific needs. The ultimate decision will be based on merit and contribution that the prospective candidate will bring to the Board.

The Board considers that considerable diversity perspectives exist in the existing Board of the Company, including gender, age, educational background, professional experience, skills and knowledge. The target to avoid a single gender Board has been met. The Board is now made up of individual Directors who each bring with them unique knowledge and experience in the industrial, financial, legal and information technology sectors. The Company shall continue to maintain its Board diversity and, when there is any vacancy to fill, to promote the specific objective of gender and age diversity without compromising the quality of the Board.

The Company is dedicated to develop gender equality as a part of the organization culture across different divisions of the entire Group. As at 31 December 2023, the workforce (including senior management) of the Group was composed of 44.5% male and 55.5% female.

The Company is committed to achieving high standards of corporate governance to safeguard the interests of shareholders and to enhance corporate value and accountability.

A Terms of Reference has been adopted for the purpose of setting out the corporate governance duties to be performed by the Board, including (but not limited to) development of the Company's policies and practices on corporate governance and making recommendations on changes and updating, review of the training and continuous professional development of Directors and senior management, and monitor the Company's policies and practices on compliance with legal and regulatory requirements.

During the year ended 31 December 2023 the Board has conducted an annual review of the policies and practices on corporate governance of the Company.

風險管理及內部監控

董事會對維持本集團適當而有效之風險管理及內部監控系統負有整體責任，並分別透過風險管理委員會及審核委員會檢討該等系統之有效性。

董事會以持續識別、分析、評估及管理風險為基礎，建立一套全面的風險管理系統。集團內各部門須自行負責及管理其本身之風險，另外亦已成立多個向風險管理委員會匯報之管理委員會，負責監察本集團不同的風險管理範疇。該等工作有助獨立查核個別部門之風險管理系統之成效。本公司之獨立內控合規部（「內控合規部」）獲指派專責內部審核職能，定期對本集團風險管理及內部監控系統進行內部檢討及測試，涵蓋財務、營運、合規、風險評估及風險應對措施的監控。由本集團行政人員組成之各個管理團隊及委員會定期開會，檢討內控合規部進行內部審核工作之發現及意見，並提出相關建議。管理團隊及委員會之行政人員亦確保監控弱點已向有關部門有效溝通，並監察有關部門其後就其建議作出之行動。內控合規部定期向風險管理委員會及審核委員會匯報其主要發現並提出意見，以助該等委員會分別評核本集團風險管理及內部監控系統是否有效。風險管理委員會及審核委員會再向董事會作出匯報，以供董事會每年從中作出本身之見解。

RISK MANAGEMENT AND INTERNAL CONTROL

The Board has overall responsibility for maintaining appropriate and effective risk management and internal control systems of the Group and reviewing their effectiveness through the Risk Management Committee and the Audit Committee, respectively.

The Board has established a comprehensive risk management system based on identification, analysis, evaluation and management of risks on an ongoing basis. Each department under the Group is required to own and manage its own risks. A number of management committees reporting to the Risk Management Committee have been established to monitor different aspects of risk management for the Group. Such work serves to provide an independent checking of the effectiveness of the risk management system of individual departments. The independent Internal Compliance Control Department ("ICC") of the Company is delegated with the internal audit function to conduct regular internal reviews and testings of the Group's risk management and internal control systems covering financial, operational, compliance, risk assessment and risk response implementation controls. The respective management teams and committees which comprise relevant executives of the Group meet regularly to review the findings and opinions of internal audits conducted by the ICC and make relevant recommendations. The executives from the management teams and committees also ensure the control weaknesses are effectively communicated to the relevant departments and monitor the follow-up actions in response to their recommendations. The ICC regularly reports its major findings and advice to the Risk Management Committee and the Audit Committee and assists them to evaluate the effectiveness of the Group's risk management and internal control systems, respectively. The Risk Management Committee and the Audit Committee report back to the Board for forming its own view on an annual basis.

審核委員會每年檢討本集團在會計、財務匯報及內部審核職能方面的資源是否充足，相關員工的資歷、經驗及培訓又是否足夠，從而確保監控程序得以持續實施且行之有效。

本集團風險管理及內部監控系統旨在提供合理而非絕對之保障，以防範出現重大錯誤陳述或損失，並管理而非消除營運系統失效之風險，從而令本集團可達到其目標。於二零二三年度，董事會已分別透過風險管理委員會及審核委員會檢討本集團之風險管理及內部監控系統，並認為該等系統為有效且足夠。

本公司致力達致及維持最高水平的透明度、廉潔與問責。與本公司反貪污政策相輔相成，舉報政策已獲採納以公平公正地管治及處理僱員及業務夥伴就財務申報、內部監控或與本集團有關之其他事宜的任何可疑不當行為或瀆職行為提出之關注。本公司現有的舉報政策不接受不具名舉報，因為本公司認為不具名舉報難以跟進及獲得資料以進行有效調查。此外，根據本公司工廠的經驗，倘本公司接受不具名舉報，則其預計將收到大量不具名舉報，這將對本公司的管理資源造成過度負擔。然而，本公司將盡一切努力對所有舉報嚴格保密。調查人員與舉報人之間的所有溝通均受到嚴格保護，以確保舉報人不會遭受報復或指責。除非本公司有法律義務向任何政府部門透露舉報人的身份及其他資料，否則未經舉報人同意，將不會披露其身份。

RISK MANAGEMENT AND INTERNAL CONTROL (continued)

The Audit Committee annually reviews the adequacy of resources and qualifications, experience and training of the staff responsible for accounting, financial reporting and internal audit functions to ensure that ongoing control process are in place and functioning effectively.

The purpose of the Group's risk management and internal control systems is to provide reasonable, but not absolute assurance against material misstatement or loss and to manage rather than eliminate risks of failure in operational system in order to achieve the Group's objectives. For the year of 2023 under review, the Board, through the Risk Management Committee and the Audit Committee, has reviewed the Group's risk management and internal control systems, respectively and considered them effective and adequate.

The Company is committed to achieving and maintaining the highest standards of openness, probity and accountability. Complementary with the Anti-Corruption Policy of the Company, the Whistleblowing Policy has been adopted to govern and deal with fairly and properly concerns raised by our employees and business partners about any suspected misconduct or malpractice regarding financial reporting, internal controls or other matters related to the Group. The existing Whistleblowing Policy of the Company does not accept anonymous reporting because the Company believes it will be difficult to follow up and obtain information for an effective investigation. Also, based on experience in the Company's factories, the Company would expect an abundance of anonymous reporting if anonymous reporting was to be accepted and this would unduly burden the Company's management resources. Nevertheless, the Company will make every effort to treat all reporting in a strictly confidential manner. All communications between the investigator and the whistleblowers are strictly protected to ensure that no reprisal or blame would be directed against the whistleblowers. The identity of the whistleblower will not be disclosed without his/her consent, unless the Company is legally obliged to reveal the whistleblower's identity and other information to any government authorities.

One or more shareholders holding at the date of deposit of the requisition not less than one-tenth (1/10) of the paid-up capital of the Company carrying the right of voting at general meetings of the Company on one vote per share basis, shall at all times have the right, by written requisition sent to the Board of Directors or Company Secretary at the Company's registered office at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and its principal office at 17/F, C-Bons International Center, No. 108 Wai Yip Street, Kwun Tong, Kowloon, Hong Kong, to require a SGM to be called by the Board of Directors for the transaction of any business or resolution specified in such requisition; and such meeting shall be held (in the form as may be determined by the Board in accordance with Bye-law 67 of the Company) within two (2) months after the deposit of such requisition.
2. The written requisition must state the purposes of the SGM, signed by the shareholder(s) concerned and may consist of several documents in like form, each signed by one or more of those shareholders.
3. If the requisition is in order, the Company Secretary will ask the Board of Directors to convene a SGM by serving sufficient notice in accordance with the statutory requirements to all the registered shareholders. If within twenty-one (21) days of the deposit of such requisition the Board fails to proceed to convene the SGM, the requisitionists themselves may do so in accordance with the provisions of Section 74(3) of the Bermuda Companies Act 1981.

1. The Company holds an annual general meeting ("AGM") every year, and may hold a general meeting known as a special general meeting whenever necessary.
2. Shareholder(s) of the Company holding (i) not less than one-twentieth (1/20) of the total voting rights of all shareholders having the right to vote at the general meeting; or (ii) not less than 100 shareholders, can submit a written request stating the resolution intended to be moved at the AGM; or a statement of not more than 1,000 words with respect to the matter referred to in any proposed resolution or the business to be dealt with at a particular general meeting.
3. The written request/statements must be signed by the shareholder(s) concern and deposited at the Company's registered office at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and its principal office at 17/F, C-Bons International Center, No. 108 Wai Yip Street, Kwun Tong, Kowloon, Hong Kong, for the attention of the Company Secretary of the Company, not less than six (6) weeks before the AGM in the case of a requisition requiring notice of a resolution and not less than one (1) week before the general meeting in the case of any other requisition.

貴集團於二零二三年十二月三十一日持有的存貨為港幣372,000,000元。貴集團依據產品週期及存貨賬齡對滯銷存貨貫徹應用一套特定的撥備方法。The Group held inventory of HK\$372 million as at 31 December 2023. It consistently applies a specific provisioning methodology for slow moving inventory based on products life cycle and inventory ageing.

我們聚焦於審計此範疇是因為撥備估計具有高度的估計不確定性及其財務重要性。由於識別有陳舊及滯銷風險的存貨以及參考產品週期對陳舊原材料的可能使用情況作出評估涉及重大判斷，因此，存貨撥備具有重大的固有風險。

We focused on auditing this area because the estimation of provision is subject to high degree of estimation uncertainty and its financial significance. The inherent risk in relation to the inventory provision is considered significant due to significant judgements involved in identifying the inventories associated with risk of obsolescence and slow moving and evaluating the possible utilisation of the aged raw materials by making reference to products life cycle.

KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Key audit matter identified in our audit is related to estimated provision for inventory.

We also evaluated, on a sample basis, the assumptions and estimates applied by management to determine the possible utilisation of aged raw materials by making reference to the products life cycle without contradictory evidence noted.

我們已在抽樣基準上評估及測試計算所用的存貨賬齡的準確性，亦曾採用二零二三年十二月三十一日的存貨賬齡及管理層釐定的產品週期重新計算存貨撥備。

We evaluated and tested, on a sample basis, the accuracy of the ageing profile of the inventory used in the calculation. We performed a recalculation of the inventory provision using the ageing profile of the inventory as at 31 December 2023 and the products life cycle determined by management.

1 一般資料

1 GENERAL INFORMATION

Wong's International Holdings Limited (the "Company") and its subsidiaries (together the "Group") are principally engaged in the development, manufacture, marketing and distribution of electronics products as well as property holding.

The Company is an exempted limited liability company incorporated in Bermuda. The address of its registered office and principal place of business are Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and 17/F., C-Bons International Center, No.108 Wai Yip Street, Kwun Tong, Kowloon, Hong Kong, respectively.

The Company has its primary listing on the Main Board of The Stock Exchange of Hong Kong Limited.

These consolidated financial statements are presented in Hong Kong dollars, unless otherwise stated. These consolidated financial statements have been approved for issue by the Board of Directors on 22 March 2024.

Subsidiaries are all entities (including structured entities) over which the Group has control. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

The acquisition method of accounting is used to account for business combinations by the Group.

Intercompany transactions, balances and unrealised gains on transactions between group companies are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the transferred asset. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Depreciation of property, plant and equipment is calculated using the straight-line method to allocate their costs to their residual values over their estimated useful lives, as follows:

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.2.6).

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in the consolidated income statement.

Investment properties, principally comprising leasehold land and buildings, are held for long-term rental yields or for capital appreciation or both, and that are not occupied by the companies in the Group.

Investment properties comprise land held under operating leases and buildings held under finance leases. Land held under operating leases are accounted for as investment properties when the rest of the definition of an investment property is met. In such cases, the operating leases concerned are accounted for as if they were finance leases.

Investment properties are measured initially at its cost, including related transaction costs. After initial recognition, investment properties are carried at fair value, representing open market value determined at each reporting date by external valuers at least annually. Fair value is based on active market prices, adjusted, if necessary, for any difference in the nature, location or condition of the specific asset. If this information is not available, the external valuers use alternative valuation methods such as recent prices on less active markets or discounted cash flow projections. Cash and cash equivalents includes cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction from the proceeds.

Financial guarantee contracts are recognised as a financial liability at the time the guarantee is issued. The liability is initially measured at fair value and subsequently at the higher of the amount determined in accordance with the expected credit loss model under HKFRS 9 “Financial Instruments” and the amount initially recognised less, where appropriate, the cumulative amount of income recognised in accordance with the principles of HKFRS 15 “Revenue from Contracts with Customers”.

The fair value of financial guarantees is determined as the present value of the difference in cash flows between the contractual payments under the debt instrument and the payments that would be required without the guarantee, or the estimated amount that would be payable to a third party for assuming the obligations.

Where guarantees in relation to loans or other payables of subsidiaries or associate are provided for no compensation, the fair values are accounted for as contributions and recognised as part of the cost of the investment in the financial statements of the Group.

Grants from the government are recognised at their fair values where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the consolidated income statement over the period necessary to match them with the costs that they are intended to compensate.

Government grants relating to the purchase of property, plant and equipment are initially included in liabilities as deferred government grants and when such property, plant and equipment are built or purchased, the received government grants are recognised in consolidated income statement on a systematic basis over the expected useful lives of the related assets.

2.3.6 Dividend distribution

Dividend distribution to the Company's shareholders is recognised as a liability in the Group's and the Company's financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

本集團的業務承受著多類財務風險：市場風險（包括外匯風險及現金流量利率風險）、信貸風險及流動資金風險。本集團的整體風險管理計劃專注於金融市場的不可預測性，並尋求盡量減低對本集團財務表現可能產生之不利影響。本集團利用衍生金融工具對沖若干風險。

(a) 市場風險

(i) 外匯風險

本集團經營國際業務，故面對不同貨幣所產生之外匯風險。本集團之外幣資產、負債及交易主要以中國人民幣（「人民幣」）及美元（「美元」）計值。該等貨幣並非與該等結餘有關的本集團若干附屬公司之功能貨幣。外匯風險主要源自未來商業交易、已確認資產及負債以及以人民幣及美元計值之淨投資。

3 FINANCIAL RISK MANAGEMENT

3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk and cash flow interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance. The Group uses derivative financial instruments to hedge certain risk exposures.

(a) Market risk

(i) Foreign exchange risk

The Group operates internationally and is exposed to foreign exchange risk arising from various currency exposures. The Group's foreign currency assets, liabilities and transactions are principally denominated in Chinese renminbi ("RMB") and United States dollars ("US\$"). These currencies are not the functional currencies of certain subsidiaries of the Group to which these balances related. Foreign exchange risk mainly arises from future commercial transactions, recognised assets and liabilities and net investments denominated in RMB and US\$.

本集團透過設置港幣、美元及人民幣銀行賬戶緩減此項風險，本集團使用該等賬戶支付以該等貨幣計值之交易。

本集團在中國內地設有若干投資，其資產淨值以人民幣計值。人民幣與外幣之兌換，須遵照中國內地政府頒佈之外匯管制規則和法規。

於二零二三年十二月三十一日，就以人民幣為其功能貨幣的集團公司而言，倘人民幣兌美元貶值／升值5%（二零二二年：5%），而所有其他可變因素保持不變，本年度除稅後利潤應增加／減少（二零二二年：增加／減少）港幣16,347,000元（二零二二年：港幣16,892,000元），主要來自換算以美元計值的應收及應付貿易賬款以及現金及現金等價物的外匯收益／虧損（二零二二年：外匯收益／虧損）。

(i) Foreign exchange risk (continued)

The Group mitigates this risk by maintaining HK\$, US\$ and RMB bank accounts which are used by the Group to pay for the transactions denominated in these currencies.

The Group has certain investments in Mainland China, whose net assets are denominated in RMB. The conversion of RMB into foreign currencies is subject to the rules and regulations on the foreign exchange control promulgated by the Mainland China government.

At 31 December 2023, for the group companies with RMB as their functional currency, if RMB had weakened/strengthened by 5% (2022: 5%) against US\$ with all other variables held constant, post-tax profit for the year would have been HK\$16,347,000 (2022: HK\$16,892,000) higher/lower (2022: higher/lower), mainly as a result of foreign exchange gains/losses (2022: foreign exchange gains/losses) on translation of US\$-denominated trade receivables and payables and cash and cash equivalents.

由於港幣與美元掛鈎，本集團管理層認為有關的外匯風險甚微。

At 31 December 2023, for the group companies with HK\$ as their functional currency, if HK\$ had weakened/strengthened by 5% (2022: 5%) against RMB with all other variables held constant, post-tax profit for the year would have been HK\$134,000 (2022: HK\$157,000) lower/higher (2022: lower/higher), mainly as a result of foreign exchange losses/gains (2022: foreign exchange losses/gains) on translation of RMB-denominated trade receivables and payables and cash and cash equivalents.

As the Hong Kong dollar is pegged to the US\$, the Group management considers that the relevant foreign exchange risks are minimal.

本集團因計息資產及負債利率變動之影響而面臨利率風險。現金流量利率風險指市場利率變動而將影響可變利率金融工具產生之現金流量之風險。本集團之計息資產主要包括銀行存款。本集團之浮動利率借款將受當前市場利率波動影響，並將使本集團面臨現金流量利率風險。

本集團使用利率掉期管理其現金流量利率風險。一般而言，本集團以浮動利率籌措借款，並掉為假使本集團直接按固定利率借款可取得較低之固定利率。

(ii) Cash flow interest rate risk

The Group is exposed to interest rate risk through the impact of rate changes on interest bearing assets and liabilities. Cash flow interest rate risk is the risk that changes in market interest rates will impact cash flows arising from variable rate financial instruments. The Group's interest bearing assets mainly include deposits at bank. The Group's floating rate borrowings will be affected by fluctuation of prevailing market interest rates and will expose the Group to cash flow interest rate risk.

The Group manages its cash flow interest rate risk by using interest rate swaps. Generally, the Group raises borrowings at floating rates and swaps them into fixed rates that are lower than those available if the Group borrowed at fixed rates directly.

本集團之信貸風險主要來自現金及銀行存款以及客戶之信貸承擔，例如應收貿易賬款、按公允價值計入其他全面收入的金融資產、訂金及其他應收賬款。現金及銀行存款之信貸風險有限，原因是本集團主要將存款存放於高信貸評級之銀行，管理層預料不會因該等銀行違約而導致任何虧損。

As at 31 December 2023, if interest rate on bank borrowings had been 1% (2022: 1%) higher/lower with all variables held constant, post-tax profit for the year would have been HK\$2,427,000 (2022: HK\$4,367,000) lower/higher (2022: lower/higher), mainly as a result of higher/lower interest expense on floating rate bank borrowings, which are not hedged with interest rate swap contracts.

(b) Credit risk

Credit risk of the Group mainly arises from cash and bank deposits as well as credit exposures to customers such as trade receivables, financial assets at fair value through other comprehensive income, deposits and other receivables. The credit risk on cash and bank deposits is limited because the Group mainly places the deposits in banks with high credit rating and management does not expect any losses from non-performance by these banks.

為管理信貸風險，本集團已考慮相關擔保及與對手方之長期業務關係。本集團已制訂政策，確保按信貸條款獲銷售產品之客戶均具有良好信貸紀錄，而本集團亦會定期評估客戶的信貸狀況。本集團通常不要求貿易債務人提供抵押品。於二零二三年十二月三十一日，首五名（二零二二年：五名）客戶佔本集團年末應收貿易賬款總結餘83%（二零二二年：85%），故本集團面對信貸風險集中的情況。管理層經考慮該等客戶的財務狀況及過往經驗，認為有關該等客戶的信貸風險十分輕微。

本集團其他金融資產（包括受限制現金、短期銀行存款、現金及現金等價物、按公允價值計入其他全面收入的金融資產、訂金及其他應收賬款）之信貸風險來自對手方違約，而面臨的最大信貸風險相等於該等工具之賬面值。

(i) Risk management

To manage credit risk, the Group has considered the underlying security and the long-established business relationship with the counterparty. The Group has policies in place to ensure that sales of products on credit terms are made to customers with an appropriate credit history and the Group performs periodic credit evaluations of its customers. Normally the Group does not require collaterals from trade debtors. As at 31 December 2023, the Group has a concentration of credit risk given that the top five (2022: five) customers account for 83% (2022: 85%) of the Group's total year end trade receivable balance. Management considers that the credit risk in respect of these customers is minimal after considering the financial position and past experience with these customers.

The credit risk of the Group's other financial assets, which comprise, restricted cash, short-term bank deposits, cash and cash equivalents, financial assets at fair value through other comprehensive income, deposits and other receivables, arises from default of the counterparty, with a maximum exposure equal to the carrying amounts of these instruments.

本集團應用香港財務報告準則第9號計量預期信貸虧損之簡化方法，就所有應收貿易賬款使用年期預期虧損撥備。

為計量預期信貸虧損，應收貿易賬款會作個別評估以計提減值撥備。貿易應收賬款乃根據客戶的信貸評級、不同客戶的還款及違約記錄以及與相關客戶的持續業務關係進行評估。虧損率會進行進一步調整，以反映當前和前瞻性的宏觀經濟因素的資料以影響客戶結清應收賬款能力。本集團已經將客戶所在國家的本地生產總值指數識別為最相關的因素，並根據該等因素的預期變化相應調整歷史虧損率。

Trade receivables and deposits and other receivables are subject to the expected credit loss model.

(1) Trade receivables

The Group applies the HKFRS 9 simplified approach to measuring expected credit losses which uses a lifetime expected loss allowance for all trade receivables.

To measure the expected credit losses, trade receivables are assessed individually for provision for impairment allowance. Trade receivables have been assessed based on credit rating of the customers, the repayment and default histories of different customers and on-going business relationship with the relevant customers. The loss rates are further adjusted to reflect current and forward-looking information on macroeconomic factors affecting the ability of the customers to settle the receivables. The Group has identified the Gross Domestic Product index of the countries where the customers located to be the most relevant factor, and accordingly adjust the historical loss rate based on expected changes in these factors.

Trade receivables are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery includes, amongst other, the failure of a debtor to engage in a repayment plan with the Group.

Impairment losses on trade receivables are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

Prudent liquidity risk management implies maintaining sufficient cash and the availability of funding through an adequate amount of available credit facilities. The Directors aim to maintain flexibility in funding by keeping credit lines available.

The Group's policy is to regularly monitor its liquidity requirements, its compliance with lending covenants and its relationship with its bankers to ensure that it maintains sufficient reserves of cash and readily realisable marketable securities and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

The following tables show the remaining contractual maturities at the end of the reporting period of the Group's non-derivative financial liabilities, based on undiscounted cash flows (including interest payments computed using contractual rates or, if floating, based on rates current at the balance sheet date) and the earliest date the Group can be required to pay.

3.2 資本風險管理

本集團的資金管理目標是確保本集團能持續營運，繼續為股東提供回報並為其他持份者帶來利益，同時維持最佳的資本結構以減低資金成本。

為維持或調整資本結構，本集團可能會調整支付予股東的股息金額、向股東退回資本、發行新股份或出售資產以降低債務。

與其他同業一致，本集團以淨資產負債比率作為監控資本的基準。該比率按淨負債除以總權益計算。淨負債按總貸款及租賃負債減受限制現金、短期銀行存款以及現金及現金等價物計算。

3.2 Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

Inventories are written down to net realisable value based on an assessment of the realisability of inventories. Write-downs on inventories are recorded where events or changes in circumstances indicate that the balances may not be realised. The identification of write-downs requires the use of judgement and estimates. Where the expectation is different from the original estimate, such difference will impact the carrying value of inventories and write-downs of inventories in the periods in which such estimate has been changed.

(b) Estimated impairment of receivables

The loss allowance for financial assets is based on assumptions about risk of default and expected loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward looking estimates at the end of each reporting period. Details of the key assumptions and inputs used are disclosed in Note 3.

(c) Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amounts have been determined based on value-in-use calculations or market valuations. These calculations require the use of judgements and estimates.

The Group's management determines the estimated useful lives, and related depreciation charges for its property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. Management will increase the depreciation charges where useful lives are less than previously estimated lives. It will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold. Actual economic lives may differ from estimated useful lives. Periodic review could result in a change in depreciable lives and therefore depreciation expense in future periods.

(f) Income taxes and deferred income tax

The Group is subject to income taxes in various jurisdictions. Significant judgement is required in determining the worldwide provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be required. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the reporting date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled. When the expectations are different from the original estimates, such differences will impact the recognition of deferred tax assets and income tax charges in the period in which such estimates have been changed.

(g) Provision for write-down of stock of completed properties

In assessing the net realisable value of stock of completed properties, the management took reference to the independent qualified professional valuations. The assessment is dependent on certain key assumptions that require subjective assumptions and significant management estimates, including adjustment factors on comparable market transactions used in valuation of completed properties held for sale.

For the general reserve, the PRC entities are required to transfer at least 10% of its net profit, as determined under the PRC accounting rules and regulations, to the statutory general reserve. The transfer to this reserve must be made before distribution of dividends to equity owners. When the balance of reserve reaches 50% of each entity's registered capital, any further appropriation is optional. The general reserve can be utilised to offset prior year losses or be utilised for the issuance of bonus shares.

For the enterprise expansion fund, the percentage of appropriation is determined annually by the directors. The enterprise expansion fund can be utilised for the development of business operations.

During the year ended 31 December 2023, HK\$1,217,000 (2022: HK\$2,333,000) was appropriated to the general reserve and the enterprise expansion
